1. Learned counsel for the GNCTD states that it is in the midst of talks with the District Authorities of the Tis Hazari Courts as well as Rouse Avenue Court to install Advanced Cardiovascular Life Support ('ACLS') service in both the Courts.
2. She further states that GNCTD, as of now, has provided three ACLS ambulances at the three major interchange metro stations, namely, Kashmere Gate, Rajiv Chowk and Hauz Khas.
3. Learned counsel for DMRC states that there is space available at the aforesaid three major interchange metro stations for installation of the ACLS service.
4. In view of the aforesaid statement, learned counsel for DMRC and GNCTD are directed to explore the possibility of installation of ACLS facility at the three major interchange metro stations forthwith.
5. Let a fresh Status Report be filed before the next date of hearing.
6. List on 1st August, 2023.
