**HON'BLE MR. JUSTICE MUNNURI LAXMAN**

**Order**

**07/04/2026**

1. Heard.
2. All these writ petitions are filed by the volunteers of the Home Guards Department. The writ petitions have been filed challenging the alleged oral termination of their services.
3. During the pendency of all these writ petitions, 81 candidates were screened for fresh consideration in the new recruitment process and the results of screening is not known till date.
4. The limited grievance of the petitioners in the present cases is that some persons were only selected for the screening, ignoring the claims of the petitioners who were also entitled for screening. Further grievance of the petitioners is that the screening has to be done among the petitioners only. However, in the present case the screening is done with fresh candidates. There is unequal competition resulting in deprivation of fair participation in the selection process.
5. Learned counsel for the respondents submitted that the screening of 81 candidates was allowed upon directions given by this Court as an interim measure and the screening is subject to meeting the eligibility criteria for engaging; availability of the vacancies and desire of the Government to fill up those vacancies.





6. This Court finds that any competition must be among equals and not unequals. If the petitioners are already having some experience by engaging them as volunteers in the Home Guards Department and if the Government chooses to fill up any vacancies available for recruitment to the post of volunteers in the Home Guards Department, the petitioners are required to be screened initially and whoever is found eligible for recruitment, they are required to be taken into services. The engagement is subject to the desire of the Government to engage in the vacant posts and screening itself does not confer any right on the petitioner, except the right to be considered in the event the Government chooses to proceed with the recruitment to fill up the volunteers working in the Home Guards Department. Such screening must be among the petitioners only.

7. With the aforesaid directions, all these writ petitions are ***disposed of.***

8. All pending applications, if any, stand disposed of.
