3. Meanwhile, the applicant(s) shall be allowed to continue in service till the age of 61 years, provided they have not already been released from the service.
4. Having regard to the fact that this issue is likely to arise in all the States, let notice be issued to all the High Courts, States, Union Territories and the Union of India.
