UPON hearing the counsel the Court made the following
O R D E R

I.A. No.171298/2026 in W.P.(C) No. 737/2025

1. Issue notice, returnable on 17.09.2026.
2. Mr. Prateek Kumar, learned counsel, accepts notice on behalf of Election Commission of India (ECI).
3. Let the ECI file its reply to the application. Moreover, the ECI shall specify: (i) how many appeals are presently pending before the subject-Election Tribunals; (ii) how many appeals have been decided thus far; and (iii) how many appeals have been instituted at the instance of voters whose names were excluded or deleted.
4. The ECI shall also disclose the proposed procedure or

mechanism for streamlining the disposal process of the pending appeals.

5. Lastly, during the course of hearing, some information pertaining to the aforementioned appeals, reportedly obtained under the Right to Information Act, 2005, has also been handed over; a copy whereof has been tendered to the learned counsel for the ECI, so as to enable him to have instructions in that regard also.

6. Post the matters on 17.09.2026.
