- 2. Shri Jayant Bhushan, learned senior counsel, submits that some of the States have filed their affidavits before this Court. It is further submitted that the statements made in the affidavits are away from ground realities. He also submits that though many of the women would like to leave the protected homes, which are

nothing else but a prison, they are not permitted to do so.

- 3. We direct that all such State Governments, who have not filed their affidavits, shall do so within a period of six weeks from today.
