# UPON hearing the counsel the Court made the following O R D E R

### IA No. 18902/2024

- In his order dated 25 January 2024, the Speaker of the Maharashtra Legislative Assembly, has indicated that the cross-examination of the witnesses for the respondents could not be concluded and that, by consent of the parties, the following time schedule has been prescribed:
  - "(a) 29<sup>th</sup> January 2024: Continuation of cross examination of Respondents' witnesses. The same shall be concluded on the said date.
