SUBMISSION GUIDELINES

1. Interested authors are requested to submit their contributions via the link given at the end of this post. The submissions should be in MS Word attachments and in .doc/.docx format.
2. No more than 3 authors are allowed for one article.
3. All submissions must include a cover letter that provides the following details:
 - a. Name(s) of the author(s)
 - b. Institutional affiliation(s)
 - c. Academic qualifications, including degrees completed
 - d. Title and category of the submission
 - e. Email addresses of all co-authors.
4. The body of the submission must not contain any identification of the author(s), including institutional affiliation. Such details should only be mentioned in the cover letter.
5. All submissions will be reviewed on a rolling basis.

- Submissions must be made through the link provided at the end of the post.
- Submissions will be accepted on a rolling basis and acceptance will be communicated via email within two weeks.
