

The learned Government Pleader takes notice for the second respondent. Issue notice by speed post to respondents 3 to 7.

The matter raises a serious concern. The petitioner is a practicing lawyer of this Court has filed this writ petition. According to him, the Indian Reality Show named as Big Boss, which telecast an incidents of physical assault in contraventions to the directives issued by the Union Government. The petitioner specifically points out Exts.P2 to P4 advisories. Ext.P1 is the image captured from the reality shows the physical assault.

In such circumstances, We direct 1<sup>st</sup> respondent to immediately address the violations of advisories if necessary by instructing the party respondents herein to desist from telecasting such shows in the
