In all these petitions, since common question is involved, hence with consent of the parties, these petitions have been heard together and are being decided by the present order.

Learned Senior Counsel assisted by the other counsels appearing for the petitioners submitted that the petitioners are aggrieved by the notice dated 14/15.12.2021 as well as the public notice dated 23.12.2021 issued to them by the respondent-Nagar Palika, Kotputli for removal of encroachments from the road as also the respondent-Nagar Palika has demanded the documents from the petitioners of their lawful title over the disputed land. Learned Senior Counsel further submitted that the petitioners have submitted their reply/objections pursuant to the notices issued to them but the Nagar Palika without considering their reply/objections is going to demolish their construction.

Mr. Anil Mehta, learned Additional Advocate General appearing on behalf of the respondents submitted that they will look into the reply/objections of the individual persons including the petitioners submitted by them pursuant to the notice and only after due consideration thereon, final decision shall be taken in the matter.

Heard counsel for the parties and perused the record.

Considering the submissions made by counsel for the parties, in the facts and circumstances, I deem it just and proper to direct the respondent-Nagar Palika to decide the objections submitted by the petitioners pursuant to the notice issued to them, by reasoned and speaking order within a period 30 days. However, the parties are directed to maintain the status-quo with regard to the property in disputed as it exists today, till the final decision is taken in the matter by the Nagar Palika. In the event of any adverse decision being taken by the respondent-Nagar Palika, the petitioners would be at liberty to challenge the same before the

appropriate forum. It is further directed that the respondent-Nagar Palika shall act upon on their decision after 15 days of its issuance.
