NOTIFICATION: CLAT 2024 RESULTS

The Common Law Admission Test 2024 (CLAT 2024) was conducted on Sunday, December 03, 2023, from 2:00 P.M. to 4:00 P.M. at 139 Test Centres in 25 States and 4 Union Territories across India. CLAT 2024 scores were tabulated and verified on December 08 and 09, 2023. They were placed before the Executive Committee and the Governing Body of the Consortium of NLUs (the “Consortium”) on December 10, 2023 for their consideration and approval. The Executive Committee and the Governing Body of the Consortium approved the same.

Candidates can download their official CLAT 2024 scorecards by logging into their account on the CLAT 2024 portal through the website of the Consortium.

- The duration of the test was 120 minutes (160 minutes for PwD/ SAP candidates entitled to compensatory time).
- CLAT 2024 UG had 5 sections, with a total of 120 questions. Two questions were withdrawn in the Final Answer Key and the Answer Key for one question was changed. Hence, the total number of questions is 118.
- The highest mark secured in CLAT 2024 UG is 108.

- The duration of the test was 120 minutes (160 minutes for PwD/ SAP candidates entitled to compensatory time).
- CLAT 2024 PG had one section comprising 120 questions.
- The Answer Key for one question was changed.
- The highest mark secured in CLAT 2024 PG is 104.25.

The overall attendance percentage for CLAT 2024 was 96.45%. Of the candidates who appeared for CLAT 2024, 57% are Females, 43% are Males, and 6 candidates are Transgender. The Consortium provided extensive support to all candidates who requested assistance for the test.

Participating National Law Universities will conduct the admissions process to the five-year integrated UG and PG programmes commencing in the Academic Year 2024-25 based on CLAT 2024 scores. Further details of the admissions and counselling process will be notified tomorrow, December 11, 2023 at 09:00 AM.

NOTIFICATION: GRIEVANCES FILING PROCESS

The Consortium of National Law Universities has constituted a Grievance Redressal Committee to receive and respond to any grievances that candidates may have with respect to the Common Law Admission Test 2024 (CLAT 2024).

1. Candidates may file a grievance regarding the CLAT 2024 Final Answer Keys as well as the conduct of CLAT 2024 at their respective Test Centres.
2. Grievances against the Final Answer Key may be raised **ONLY** by candidates who have submitted objections as per the Consortium's "Notification: Objections to Question Paper and Provisional Answer Key" dated December 04, 2023.
3. The portal to file grievances will open at **12 noon on December 11, 2023**.
4. Grievances received over email, support tickets on the website or phone calls will not be considered.
5. Process of filing grievances before the Grievance Redressal Committee:
 - a. Login to your CLAT account;
 - b. Click the 'Submit Grievance' button;
 - c. State the nature of your grievance;
 - d. Describe your grievance (max. 1,000 characters);
 - e. Upload supporting documents;
 - f. Submit the declaration form;
 - g. Click the Submit button.
