7. That above-said scandalous statements cannot be justified by any stretch of

logic reasoning whatsoever and are in bad taste. The damage caused to

undersigned and by extension lawyers, cannot be measured in monetary value

by any yardstick. Undersigned cannot fathom the far reaching implications of

such casual, false and derogatory comments made on the show "Hasmukh"

which are being allowed to stream/ play despite its character assassination that

is writ large.

8. That above-said vexatious statements are a constant stigma on the good-will

and unblemished image of lawyers and a constant source of annoyance for
