At least 100 advocates (reserved figure) in last three days, have either approached me or the Secretary General making a serious grievance and complaint that their matters even though filed in a single PDF, for fortnight have not been listed despite of their sincere attempts and efforts. I can give similar such 100 examples, notwithstanding your Lordship's clear instructions not to raise any objection other than vakalatnama and affidavit and circulate the matter upon an undertaking of an advocate, for days and months the Registry does not circulate the matters.

3. Shri Gaurav Chudasma is sitting in front of me. His matter was filed on 20<sup>th</sup> May, 2020, and it has not seen the light of the day, not even numbered. Mr. Apurva Kapadia is also sitting before me and he makes a complaint that though his matter is filed on 26.5.2020, despite his best efforts, he is not getting any response from the Registry. Ms. Truptiben whose surname I do not know, not only

Since other advocates have chosen not to name them, informed me that for more than 20 days, their matters are not circulated. I have on my personal whatsapp received more than 100 messages from different advocates making serious grievance for their matters not being circulated for weeks and for sometime for months. Mr. Ramanandansingh sent me whatsapp message, which reads as under,

*"Request that filling be done through hard copy because if filed is more than 25 mb than the E-mail is done through Google Drive. Thus sometime documents are not added which are relevant."*

Therefore, the humble and earnest request before your goodself is to start the court physically so that the Hon'ble Judges can

9. I would further request your goodself to call for the details from the Registry. Your goodself will find that four or five advocates have filed more than 40 to 70 matters during this lockdown and their matters have been placed not beyond three courts which to the fortune of the Bar are considered liberal judges in the matter of grant of bail, not that for the reason that Hon'ble Judges would have shown them favour but for the reason that those Hon'ble Judges are liberal in their approach. While some advocates who insisted for their matters being circulated were threatened that their matters will be listed before two or three Hon'ble courts by name if they continued insistence

10.
