Sub: Courts & Judges – Spread of Corona Virus Pandemic –
Functioning of Subordinate Courts in 29 Districts in the
State of Tamil Nadu and in the Union Territory of
Puducherry - Further Instructions issued.

In continuation of the directions issued in the High Court's Official Memorandums in the references cited, on reviewing the functioning of the Subordinate Courts in 29 districts, viz., (1) Dharmapuri, (2) The Nilgiris, (3) Krishnagiri, (4) Tiruvarur, (5) Theni, (6) Ramanathapuram, (7) Nagapattinam, (8) Karur, (9) Sivagangai, (10) Ariyalur, (11) Perambalur, (12) Erode, (13) Pudukkottai, (14) Cuddalore, (15) Namakkal, (16) Dindigul, (17) Virudhunagar, (18) Kanniyakumari, (19) Tiruppur, (20) Coimbatore, (21) Salem, (22) Thanjavur, (23) Thoothukudi, (24) Tiruchirapalli, (25) Tirunelveli, (26) Tiruvannamalai, (27) Vellore, (28) Villupuram and (29) Madurai in the State of Tamil Nadu and in the

Union Territory of Puducherry, the Hon'ble Administrative Committee directs to continue the functioning of subordinate Courts in 28 Districts (except Periyakulam Taluk in Theni District) in exclusion of Madurai District in the State of Tamil Nadu, and in the Union Territory of Puducherry, in the same manner until further orders, subject to any further decisions in this regard.
