authorities indicates that 9 Indian Citizens are missing since

February 3, 2023 while sailing in a boat from Commonwealth

of Dominica to Saint Martin and the apprehension is that they

are stuck/detained in any of the Island in the Carribean region,

or the Overseas Territories of France.

2. Taking note of the concern raised in the petition and the

communications provided by the learned counsel appearing for

the respondent No.2, we require the respondent No.2 namely

the Secretary, Ministry of External Affairs, Government of India

to coordinate with the concerned Ministry/High Commission of

India in Franace, Dominica to make an effort to find out

whereabouts of 9 missing Indian Citizens since February, 2023.

3. The affidavit of the Joint Secretary, Ministry of External

Affairs, Government of India shall be filed on the next date

fixed, to bring on record the results of the action taken by

them.
